The Illinois CDL is based on weight to drive it, you will need to know the gross vehicle weight rating (GVWR) and check the list: if you will drive (truck and trailer) also known as a combination vehicle whose trailer has a GVWR of more than 10,000 pounds and whose total GVWR with the truck is 26,001 lbs or more, you will need a Class A Commercial Drivers License.
