Can I complete a Form I-9 with a TN visa?

As an alternative to using Form I-129, TN visa workers may also "amend" their TN status by filing an application at the U.S. port-of-entry (Canadians) or at the U.S. Embassy/Consulate. This process will generally involve the same steps and documentation required for an initial TN visa application.

If a Canadian citizen is applying for the TN visa status at a land border, preflight clearance in Canada or airport in the US (see Find Out Where a Canadian Citizen Can Apply for a TN Visa for more info on this), no government forms are required for the application, unless the application was prepared by an attorney, in which case the application package will contain the Form G-28, Notice of Entry of Appearance as Attorney or Accredited Representative.

The nonimmigrant NAFTA Professional (TN) visa allows citizens of Canada and Mexico, as NAFTA professionals, to work in the United States in prearranged business activities for U.S. or foreign employers. Permanent residents of Canada and Mexico are not able to apply for TN visas to work as NAFTA professionals.

Application Overview To qualify for admission to the United States as a Registered Nurse in the TN (NAFTA Professionals) category, a Canadian or Mexican national must meet the following requirements: Hold a valid Canadian or Mexican passport. Hold a state or provincial nursing license, or hold a Licenciatura Degree.

Gather and prepare the following required documents before your visa interview: Passport valid for travel to the United States
- Your passport must be valid for at least six months beyond your period of stay in the United States (unless exempt by country-specific agreements).

Proof of professional qualifications, such as transcripts of grades, licenses, certificates, degrees, and/or records of previous employment. Resume. Proof of ability to meet applicable license requirements. Letters of reference about previous employment.
